Guidance for applicants

If you would like to apply for POGP endorsement please complete the <u>online application form</u>, providing as much information as possible.

The application will be reviewed independently by members of POGP. If successful, use of the logo will be approved subject to certain quality standards criteria and review processes.

Endorsements will be reviewed regularly by POGP, and any changes to an endorsed product/project are required to be shared with POGP.

Before completing the form, please have ready the following information:

- Membership info
- Complete information about the product/event/organisation including purpose and target audience; links to relevant websites; evidence of compliance to POGP vision and values
- Information about any conflicts of interests, personal and commercial
- Relevant timescales for development or completion and review
- Correct contact details

When reviewing the application consideration will be given to:

- POGP member involvement
- Alignment to POGP vision and values
- Target audience
- Relevance to evidence-based practice
- Corporate or commercial considerations
- Costs
- If for the public audience and consideration of accessibility and equality, diversity and inclusion factors

By completing an application, you are requesting official endorsement of your product or service by POGP, which may or may not include the use of the POGP logo.
