

## **POGP Engagement and Endorsement Guidance**

This document sets out the guidance for when POGP is asked to engage with, collaborate, support, promote or endorse an activity, development or publication that may or may not include the use of the POGP logo.

The aim is to create a clear structure for all Board and appointed POGP members for how to engage with external requests in a timely way to the greater good of POGP, the benefit of POGP members and more broadly the pelvic health community.

#### **Definitions**

**POGP** refers to the Board, subcommittees or identified individual members of POGP representing the POGP organisation.

**Product** refers to an activity, project, development, event or publication. Product does not include a device or commercial item.

**Endorsement** is when POGP are asked to formally put their name to a product that may or may not include the use of the POGP logo. Endorsement will be approved or rejected following a formal process conducted by POGP Board / subcommittee members using the POGP Endorsement Guide. If a POGP Board member or designated POGP member has been included in the project from the beginning the Endorsement process will be expedited or agreed in advance unless the participating member feels the process has become unrepresentative and no longer meets the POGP objectives for endorsement.

The use of the POGP logo is subject to quality standards being maintained.

This Guidance document does not affect POGP members promoting and endorsing products, publications and events on POGP social media platforms which are considered to be personal opinions and does not imply POGP endorsement or support.

**Engagement** describes the POGP involvement in a product that may or may not result in a collaboration, endorsement or support. A request for engagement may come from an individual, or an organisation, and may come from POGP or be directed to POGP.

### The Objectives of POGP

POGP is a registered charitable incorporated organisation (no. 1181424).

Any request for engagement, collaboration, support or endorsement will be considered according to the charity's objectives. If there is a request for POGP endorsement of a product that POGP have not previously been involved in, the POGP Endorsement Information document will be sent initially, asking for specific answers prior to POGP reviewing the product.

#### The objectives are:

- To define and promote high standards of physiotherapy practice within the areas of obstetrics, gynaecology, urology, bladder, bowel and sexual health for men and women.
- To act in the professional interest of the chartered physiotherapist working in the fields of obstetrics, gynaecology, urology, bladder, bowel and sexual health for men and women.
- To encourage and provide means by which physiotherapists may improve their specialist therapeutic skills and understanding of the speciality by promoting relevant courses, workshops and research, and facilitate professional development.
- To promote and further the role of the physiotherapist in obstetrics, gynaecology, urology, bladder, bowel and sexual health for men and women and inform members of the relevant professional and political developments in those areas.
- To foster and encourage relevant research within the speciality
- To foster mutual understanding, collaboration and inter-professional learning opportunities and facilitate good working relationships between the members of the obstetrics, gynaecology, urology, bladder, bowel and sexual health healthcare teams and their professional bodies
- To promote all aspects of health education and patient care within the relevant specialties.

#### **The Endorsement / Engagement Procedure**

Requests to POGP are received by info@pogp.co.uk and by individual POGP members and POGP Board and subcommittee members.

Communications will be screened by the POGP administrator with the support of the Chair or vice Chair and sent to the POGP Board member with the most relevant experience for initial consideration.

#### **Engagement Procedure**

A request may be reviewed by one POGP member who will then share their opinion and decision with the POGP Board for approval to engage and either support or offer

collaboration henceforth. The member decision may include a recommendation to the Board to:

- Engage through the use of the POGP Communication networks
- Agree to collaborate requiring identification of further POGP engagement which may include resource / member participation and time.

#### **Endorsement Procedure**

A request for endorsement received by POGP will follow the same process as above with a designated POGP member leading the process, using the Engagement checklist and a request for further information from the enquirer if required. Two POGP Board or appointed members, (with a third as required to resolve a difference of conclusion) will review the product and will require:

- A copy of the document which identifies:
  - 1. the title
  - 2. the format of the submission
  - 3. the authors and contributing members/organisations must be clearly identified
  - 4. its purpose and for whom it is intended
  - 5. the date of completion and publication or a proposed timescale
  - 6. where the submission is primarily held and how it will be accessed
  - 7. a clear review process in place with the date for review
  - 8. routine transparency clause and note of any possible conflict of interest both personal and commercial.
- a statement which summarizes the content and the process by which the document was developed with reference to the relevance to the physiotherapy profession and how it particularly aligns with the POGP objectives
- a clear timescale that allows sufficient time for the endorsement process to be completed in full. A shorter timescale may be considered if required.

The endorsement reviewers will also use the **Engagement checklist**

#### **Timescale**

It is expected that this process will be completed within a short timescale depending on the size of the document. Ideally within 2 weeks and up to 1 month if required.

The decision to endorse a product will be made by the Endorsement reveiwers and the Board informed. The POGP Communication subcommittee may then lead the promotion for the endorsed product.

If POGP agree to endorse a product:

- Use of the POGP logo will be subject to adherence to quality standards for the logo which will include where it may be displayed
- The logo must be displayed with the title 'POGP Excellence Matters' (
- any subsequent changes to the document/publication must be shared with POGP
- Endorsement will be assumed until the review date after which there must be resubmission to be considered for a further period of endorsement subject to changes as above

#### **Endorsement resubmission**

A previously endorsed product for review should be sent to POGP with a clear timeline for comments to be received.

The author/organisation should be asked to indicate any planned changes in the aims or format of the document, and whether any comments relevant to the review have been received or taken into consideration.

The endorsement revision procedure may be conducted as for the engagement procedure, by a designated POGP member, or may follow the endorsement procedure with the establishment of an Endorsement committee depending on the size and complexity of the product which is to be reviewed.

#### **Communicating the decision – options for replies**

#### In favour of endorsement:

POGP are delighted to have had the opportunity to review this document for endorsement.

POGP are happy to endorse / continue to endorse this document as it continues to broadly meet the objectives of our charitable organisation.

(If required) Please find attached the suggested minor changes to text (complete as required).

Additionally we would suggest a review date, and broader representation for future reviews.(add if required / relevant)

POGP have a new logo which is attached.

The image is in vector format which preserves the scale and quality of the image and it should appear as it is in colour preferably with the words "excellence matters" included.

#### In favour of engagement

POGP are happy to be involved with supporting this document / product / initiative and will.... ( add the extent to which POGP will be involved – promotion / tweet / advertising etc

#### Not in favour of endorsement

Thank you for asking POGP to consider this document / product / report for endorsement.

Two reveiwers have applied our endorsement criteria and we do not think that this sufficiently meets the aims and objectives of our organisation.

The following suggestions are made for modifications, and we would be happy to review this decision.

Or: we might turn down endorsement but agree to support the campaign etc.
